Applications are invited from the eligible local candidates for filling up of 01 (one) post of Principal, B.Ed College, Soreng in the Level 19 of Pay Matrix under Education Department, Government of Sikkim, through Direct Recruitment. All applications are invited through **online mode** only ([www.spscskm.gov.in](http://www.spscskm.gov.in))

#### **1. CONDITIONS OF ELIGIBILITY :**

Eight years of Teaching Experience in a Secondary Teachers' Education Institution after fulfillment of eligibility conditions at Sl. No. 1 &amp; 2 above.</li></ol> <p><i>Desirable: Degree/Diploma in Educational Administration /Leadership</i></p>

- All the essential qualifications must be obtained from a recognized University/Institute. By a recognized University/Institute is meant a University/Institute affiliated to UGC/Other Statutory apex bodies, or recognized by the State or Central Government as a centre of higher learning. In case of a foreign University, the Degree concerned should be recognized as equivalent to its Indian counterpart by the Association of Indian Universities.

#### **2. Age Limit:**

Should have attained the age of **21 years**, but should not have exceeded **40 years** as on **31/10/2020**, in terms of Notification No: M(3)/(55)/GEN/DOP/Pt-III DT: 03/07/2017.

#### **3. Required Documents:**

(a)	Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.
(b)	Class X & XII Mark Sheet and Certificate.
(c)	Degrees/Mark sheets in relevant fields.
(d)	No Objection Certificate from the Head of Department.
(e)	Office Order stating present post held, duly authenticating the numbers of years of service rendered in the present post.

#### 4. Other Qualifications:

(a)	<i>Should have knowledge of any of the State Languages.</i>
(b)	<i>Should be conversant with the customs and usages of Sikkim.</i>

5. Candidate should go through the advertisement and **read the instructions provided on the web page carefully before applying online. Applications received through any other mode shall not be accepted and shall be summarily rejected.**

6. The candidates are advised to apply online from our website <http://spscskm.gov.in/> on or before **04/12/2020** upto 12 midnight. Application submitted after **04/12/2020** will not be accepted by the software and SPSC will not be responsible for the same.

7. Application fee amounting to Rs 150/- only may be paid online through credit/debit card, Net Banking by Visa/Mastercard. The amount once deposited shall not be refunded or adjusted against any other purpose. Candidates belonging to **PWD Category are exempted from paying the fees.**

8. e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same is published by the Commission in the official website i.e. <http://spscskm.gov.in/>

9. Candidates are directed to bring a Photo Identity proof like (Aadhar Card, Voter Card, Driving Licence) alongwith valid e-Admit cards in the examination centre for proof of identity.

Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on **10/12/2020** and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC w.e.f. **11/12/2020** to **08/01/2021**.

11. No TA/DA is admissible for attending the examination/Interview.

12. Admission at all the stages of examination for which candidates are admitted by the Commission viz. Written Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.


13. The Commission will entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
