Applications are invited from the eligible local candidates for filling up 13 (thirteen) posts of **Fisheries Guard** on temporary regular basis in Level 6 of the Pay Matrix under Directorate of Fisheries under Department of Animal Husbandry & Veterinary Services, Government of Sikkim, through Direct Recruitment. However, during the period of Probation/Apprenticeship/Training, pay shall be governed by Notification No. 489/GEN/DOP dated: 31.10.2011.

**01. Minimum Educational Qualification:**

Degree of B.Sc (Zoology) from a recognized University.

**02. Age Limit:**

Should have attained the age of **21 years**, but should not have exceeded **30 years** as on **31<sup>st</sup> July, 2021**.

**03. Other Qualifications:**

(a)	<i>Should have knowledge of any of the State Languages.</i>
(b)	<i>Should be conversant with the customs and usages of Sikkim.</i>

**04. Required Documents:**

<b>(a)</b>	In accordance with Notification No: 44/GEN/DOP dt: 27.10.2015 candidates who are in the final year/semester of the prescribed course shall be accepted provided such candidates have cleared all previous years/semesters at the time of submission of applications and subject to submission of the final year /semester results <b>on or before the date specified</b> by the Sikkim Public Service Commission. Non-submission of the proof of essential educational qualification by prescribed date shall make the application of such candidates liable to be <b>rejected</b> without assigning any reason thereof.		
<b>(b)</b>	Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.		
<b>(c)</b>	Category Certificate issued by the competent authority of the Government of Sikkim.	<b>(d)</b>	Should have Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim.
<b>(e)</b>	No Objection Certificate from the Head of Department in case of employed candidate.	<b>(f)</b>	Marital Status certificate (for female candidate). In case of married women candidate, COI/SSC of Husband should be enclosed.

07. **SCHEME OF EXAMINATION:**

08. Candidate should go through the advertisement and **read the instructions provided on the web page carefully before applying online. Applications received through any other mode shall not be accepted and shall be summarily rejected.**
09. The candidates are advised to apply online from our website <http://spscsm.gov.in/> on or before **15.09.2021** upto 12 midnight. Application submitted after **15.09.2021** will not be accepted by the software and SPSC shall not be responsible for the same.
10. **Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on 22.09.2021 and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC w.e.f 27.09.2021 to 01.10.2021.**
11. Application fee amounting to Rs 150/- only may be paid online through Net Banking or credit and debit card, (Visa/MasterCard). The amount once deposited shall not be refunded or adjusted against any other purpose.
12. e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same shall be published by the Commission in the official website of the Commission.
13. Candidates are directed to bring a Photo Identity proof like (Aadhaar Card, Voters Card, Driving License) along with valid e-Admit cards in the examination centre for proof of identity.
14. Those candidates who qualify in the written examination will be called for the scrutiny of documents. Short listed candidates are required to submit attested Photocopies of all relevant documents on the dates specified by the Commission.
15. No TA/DA is admissible for attending the examination.
16. Admission to all the stages of examination for which candidates are admitted by the Commission viz. Written Examination shall be purely provisional and subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post shall be cancelled by the Commission without notice.
17. The Commission shall entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
18. **Any further instructions/Corrigendum/Addendum shall be uploaded only on Sikkim Public Service Commission website.**
