Applications are invited from the eligible local candidates for filling up 07 (Seven) posts of Inspector of Legal Metrology (LMO) on temporary-regular basis in Level-11 of the Pay Matrix in the Legal Metrology Unit and Consumer Protection Cell under Food and Civil Supplies Department, Government of Sikkim, through Direct Recruitment. - 2. Be a graduate in Technology from a recognized university OR
- 3. Be a graduate in Engineering from a recognized university OR
- 4. Hold a recognized Diploma in Engineering with 03 (three) years of professional experience.

## 5. Age Limit:

Should have attained the age of 18 years, but should not have exceeded 40 years as on 31/08/2021, in terms of Notification No: M(3)/(55)/GEN/DOP/Pt.III dated: 03/07/2019.

### 9. SCHEME OF EXAMINATION:

Candidates are advised to refer to <u>APPENDIX – I</u> for Detailed Scheme and pattern for the Written Examinations. The syllabus can be downloaded from the Sikkim Public Service Commission website.

- 10. Candidate should go through the advertisement and read the instructions provided on the website carefully before applying online. Applications received through any other mode shall not be accepted and shall be summarily rejected.
- 11. The candidates are advised to apply online from our website <a href="http://spscskm.gov.in/">http://spscskm.gov.in/</a> on or before <a href="27/09/2021">27/09/2021</a> upto 12 midnight. Application submitted after <a href="27/09/2021">27/09/2021</a> will not be accepted by the software and SPSC shall not be responsible for the same.
- 12. Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on 30/09/2021 and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC w.e.f. 01/10/2021 to 08/10/2021.
- 13. Application fee amounting to Rs 150/- only may be paid online through Net Banking or credit and debit card, (Visa/MasterCard). The amount once deposited shall not be refunded or adjusted against any other purpose.
- 14. e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same shall be published by the Commission in the official website of the Commission.
- 15. Candidates are directed to bring a Photo Identity proof like (Aadhaar Card, Voters Card, Driving License) along with valid e-Admit cards in the examination centre for proof of identity.
- 16. Those candidates who qualify in the written examination will be called for the scrutiny of documents. Short listed candidates are required to submit attested Photocopies of all relevant documents on the dates specified by the Commission.
- 17. No TA/DA is admissible for attending the examination.
- 18. Admission to all the stages of examination for which candidates are admitted by the Commission viz. Written Examination shall be purely provisional and subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post shall be cancelled by the Commission without notice.
- 19. The Commission shall entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
- 20. Any further instructions/Corrigendum/Addendum shall be uploaded only on Sikkim Public Service Commission website.
