a). Degree of Shastri or Acharya in Tibetan from recognized University.

- c). Must be able to read, write and converse in Bhutia/Tibetan Language.

2. Other requisites

- (2) Should have valid Local Employment Card.
- (3) Should be conversant with the customs and usages of Sikkim.
- (4) Should have knowledge of any of the State Language.

Should have attained the age of 21 years, but should not have exceeded 30 years as on 31.12.2014. The maximum age limit shall be relaxed upto 5 years in respect of candidates belonging to B.L., S.T.& S.C. & 4 yrs. for OBC (Central List) candidates and 03 yrs. for OBC(State List) candidates. 5 years for inservice regular govt. servant.
