Applications are invited from eligible local candidates for filling up of 07 (Seven) posts of Labour Inspector on temporary regular basis in PB-2 of Rs. 9300-34800 and Grade Pay of Rs. 3800 under Labour Department.

A. ELIGIBILITY CRITERIA.

1. *Minimum Educational Qualification* : *Degree in Law from a recognised University.*
2. *Other Qualifications* : *Should be conversant with the customs and usages of Sikkim.*
3. *Age* : *Should have attained the age of 18 years as on the 1st day of the month of advertisement and the upper age limit shall be as follows:*

Complete application form accompanied by (1) Attested copies of Class X & XII Mark sheets/Certificate containing Date of Birth. (2) Degree Mark Sheet and Degree Certificate in Law awarded by the University (3) Valid Local Employment Card issued by the competent authority of the Government of Sikkim, (4) Valid Certificate of Identification/Sikkim Subject Certificate and (5) Valid category certificate for BL/ST/MBC/OBC/SC certificate issued by the competent authority of the Government of Sikkim (6) No Objection Certificate from the Appointing Authority/ Head of Department in case of employed candidate.

The complete application form should reach the Secretary, Sikkim Public Service Commission, Old West Point School complex, Near Police Headquarter, Gangtok by hand or by post on or before 03:00 p.m. on 07.04.2014. No application submitted after 03:00 p.m. on 07.04.2014 will be accepted. SPSC will not be responsible for late receipt of application due to postal delay or otherwise. Application received after last date and also incomplete application forms without required documents will be summarily rejected.

The Decision of the Commission as to the eligibility of candidate for admission to the examination shall be final. The candidate on selection and during the period of probation/apprenticeship/ training/ pay shall be governed by the Notification No. 489/GEN/DOP date: 31.10.2011.

Admission at all the stages of examination for which candidates are admitted by the Commission viz: Main (written) Examination and Interview Test will be purely provisional and is subject to their satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission.
