The list of Optional Subjects, Syllabus, Scrutiny of documents and the date to fill up the preference form will be announced and uploaded in our official website shortly.

Admission to all the stages of examination for which candidates are admitted by the Commission viz Preliminary Examination, Written Examination and Viva-voce /interview will be purely provisional, subject to their satisfying the prescribed eligibility criteria. If on verification at any stage before or after the Preliminary Examination, Main (written) examination and viva-voce, if it is found that any of the above shortlisted candidates do not fulfill any of the prescribed eligibility criteria, their candidature will be rejected and the next eligible candidate as per merit in their category list will automatically be called for the Mains Written Examination.
