Applications are invited from the eligible candidates for filling up of 03 (three) posts of Principal of Sikkim Government Colleges, Namchi, Gyalshing and Burtuk under Human Resource Development Department, Government of Sikkim in the pay Band PB-5 of Rs. 37400-67000 plus Academic Grade Pay (AGP) of Rs. 10,000/-

### **CONDITIONS OF ELIGIBILITY :**

1. Minimum Educational : (a) *Post Graduate Degree in any subject with at least 55% marks or equivalent grade. (Relaxation of 5% will be given to Ph.D degree holders who have obtained Master Degree prior to 19<sup>th</sup> September, 1991.)*  
(b) *Consistently good academic record.*  
(c) *Ph.D Degree*  
(d) *15 years College teaching/ administrative experience.*  
(e) *“100% by direct recruitment and preference shall be given to local Lecturers working in various Colleges of Sikkim having Ph.D and a minimum experience of 15 (fifteen) years in their respective fields.”*  
**Desirable.**  
(a) *Honors at Degree Level*  
(b) *Knowledge in any one of the local languages, viz. Sikkimese Bhutia or Lepcha or Limboo or Nepali.*  
(c) *Candidates working in any affiliated colleges under Sikkim University and candidates holding COI/ Sikkim Subject Certificate working in other Universities may only apply.*
2. Duties of the post : *As prescribed by the Controlling Authority.*

3. Age : *Should have attained the age of 50 years, (5 years relaxable for Government Servant) as on 1<sup>st</sup> May, 2015.*  
*The maximum age limit is relaxable by five years in the case of BL/ST/SC candidates and four and three years for OBC – Central List and OBC – State List candidates, respectively.*

Applicants need not submit any documents, however the applicant should ensure that they are qualified on the date of application in all respect. Applicants will not be informed by the SPSC for any discrepancy or disqualification at personal level. However, those applicants whose forms are found to be incomplete in any manner will be summarily rejected, so all applicants are advised to ensure that they are qualified for the post.

The form should be filled up by the applicant himself/herself and submitted in the office of the Sikkim Public Service Commission on any working day between 10.30 am. To 03.30 pm along with **original Bank Receipt of State bank of Sikkim, for Rs. 150/- credited to '0051-SPSC'**. The amount once deposited shall not be refunded or adjusted against any other purpose. Applicants are also advised to attach a brief resume separately along with their application form.

The complete filled in application form should reach the Secretary, Sikkim Public Service Commission, Old Tourism Office, M. G. Marg, Gangtok by hand or by post **on or before 03.00 pm. On 5<sup>th</sup> June, 2015.**

No application submitted after **03.00 pm. On 5<sup>th</sup> June, 2015** will be accepted. SPSC will not be responsible for late receipt of application due to postal delay or otherwise. **For the benefit of the applicants a DROP BOX has been provided for the convenience of the applicants in the SPSC Office.**

One stamp size photograph should be affixed on the application form in the space provided and one identical stamp size photograph with the applicants name on the back side of the photograph should be submitted along with the application form.

Before filling the application form, applicant should go through the advertisement and accordingly they should fill the forms.

No TA/DA is admissible for attending the examination/Interview.

**Admission at all the stages of examination for which applicants are admitted by the Commission viz. Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that applicant do not fulfill any of the eligibility**

**conditions, their candidature for the post will be cancelled by the Commission without notice.**

**The Commission will not entertain any application on review or RTI/Correspondence till the entire process of recruitment is complete.**
