Application are invited from the eligible candidates for filling up of 04 (four) posts of Assistant Engineer (Mech.) on temporary regular basis in the pay scale of Rs. 7000-225-11500, under various Department, Government of Sikkim.

CONDITIONS OF ELIGIBILITY.

1. *Minimum Educational Qualification* : *Degree in (Mech.) Engineering from a recognized University..*

2. *Other Qualification* : (1) *Preference will be given to Sikkim Govt. Stipendary/Seat reserved for State of Sikkim.*
(2) *Should be conversant with the custom and usages of Sikkim.*
(3) *Should have knowledge of any of the State Language viz: Nepali/ Sikkimese - Bhutia / Lepcha / Limboo.*
(4) *Should have Local Employment Card.*

3. *Age* : *Should have attained the age of 21 years but, should not have attained the age of more than 30 years as on 01.04.2007. The maximum age limit shall be relaxed up to 5 years in respect of candidates belonging to SC and ST, 3 years in respect of candidates belonging to MBC & OBC and up to 40 years in respect of Government Servants.*
