- 1. Minimum Educational: Qualification** **Doctorate of Medicine (DM) or *Magister Chirurgiae* (M. Ch.) from a recognized University strictly as per norms of Medical Council of India.**

3. Other Qualifications:

(a)	Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.
(b)	Degrees in relevant fields.
(c)	Marital Status (for female candidate). In case of married women candidate, COI/SSC of Husband should be enclosed.
(d)	Experience Certificates.
(e)	Date of Birth Certificate.
(f)	No Objection Certificate from the Head of Department in case of employed candidate.

- 4.** Candidates will be selected through Interview/ Viva-Voce and the candidature of the candidates will be recommended for approval of the Government by the Commission, on the basis of their performance in the Interview/ Viva-Voce.
- 5.** Candidate should go through the advertisement and **read the instructions provided on the web page carefully before applying online. Applications received through any other mode shall not be accepted and summarily rejected.**
- 6.** Application fee amounting to Rs 150/- only may be paid online through credit/debit card, Net Banking by Visa/Mastercard. The amount once deposited shall not be refunded or adjusted against any other purpose.

7. The candidates are advised to apply online from our website <http://spscskm.gov.in/> on or before **14/01/2019** upto 12 midnight. Application submitted after **14/01/2019** will not be accepted by the software and SPSC will not be responsible for the same.
 8. **Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on 17/01/2019 and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC on 18/01/2019 & 19/01/2019, respectively.**
 9. All eligible candidates are required to produce their documents in original for scrutiny in the office of SPSC w.e.f 22/01/2019 to 24/01/2019 from 1:00 pm to 4:00 pm. **Specific date and time for scrutiny will be intimated to the candidate telephonically.**
- Admission slip for Interview will be issued to only those candidates whose documents are found to be complete in all respect.
10. No TA/DA is admissible for attending the Interview/viva-voce.
 11. Admission at all the stages of examination for which candidates are admitted by the Commission will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without further notice.
