Applications are invited from the eligible local candidates for filling up of 03 (three) posts of Assistant Programmer in the PB-2 of Rs 9300-34800 plus Grade Pay of Rs 3800/- under Sikkim State Sub-Ordinate Information Technology Service through Direct Recruitment. All applications are invited through **online mode** ([www.spscskm.gov.in](http://www.spscskm.gov.in)).

However, during the period of Probation/Apprenticeship/Training, pay shall be governed by Notification No: 489/GEN/DOP dated: 31.10.2011.

**CONDITIONS OF ELIGIBILITY FOR APPEARING IN THE EXAMINATION.**

**1. Minimum Educational Qualification :**

**Full time course in Bachelor of Computer Application Degree (BCA) from a recognized University/Institute or Full time course in Bachelor of Science in Information Technology B.Sc. (IT) or 03 (three) years Engineering Diploma (Computer or Information Technology or Electronic or Electronic & Communication) from a recognized University/Institute or Science graduate from a recognized university with "A" level course certification from National Institute of Electronic and Information Technology (NIELIT)/Government recognized Institute.**

**2. Other Qualifications:**

<b>(a)</b>	Age: Should have attained the age of <b>18 years</b> , but should not have exceeded <b>40 years</b> as on <b>31/05/2018</b> , in terms of Notification No: M(3)/(55)/GEN/DOP/Pt-III DT: 03/07/2017.
<b>(b)</b>	Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.
<b>(c)</b>	Should have knowledge of any of the State Languages.
<b>(d)</b>	<i>Should be conversant with the customs and usages of Sikkim.</i>
<b>(e)</b>	Category Certificate issued by the competent authority of the Government of Sikkim.
<b>(f)</b>	Should have Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim.
<b>(g)</b>	No Objection Certificate from the Head of Department in case of employed candidate.
<b>(h)</b>	Marital Status (for female candidate).

#### **4. SCHEME OF EXAMINATION:**

5. The candidates are advised to apply online from our website <http://spscskm.gov.in/> on or before **07/07/2018** upto 12 midnight. Application submitted after **07/07/2018** will not be accepted by the software and SPSC will not be responsible for the same.

6. Candidate should go through the advertisement and **read the instructions provided on the web page carefully before applying online. Applications received through any other mode shall not be accepted and summarily rejected.**

7. Application fee amounting to ₹150/- only may be paid online through credit/debit card, Net Banking by Visa/Mastercard. The amount once deposited shall not be refunded or adjusted against any other purpose.

8. e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same will be published by the Commission in the official website of the Commission.

9. Candidates are directed to bring a Photo Identity proof like (Aadhaar Card, Voters Card, Driving License) alongwith valid e-Admit cards in the examination centre for proof of identity.

**10. Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on 17/07/2018 and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC w.e.f. 30/07/2018 to 07/08/2018.**

11. Those candidates who qualify in the written examination will be called for the scrutiny of documents before the conduct of viva-voce/interview in the ratio as fixed by the Commission. Short listed candidates are required to submit attested Photocopies of all relevant documents on the dates specified by the Commission.

12. No TA/DA is admissible for attending the examination/Interview.

13. Admission at all the stages of examination for which candidates are admitted by the Commission viz. Written Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.

14. The Commission will entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
